IB Competition Terms and Condition

- For participating in the IB Competition, you need to register for the contest providing the details requested (first & last name, nickname, telephone, email, country) and be over 18 years old. All details provided during the registration process should be correct (i.e. full name details to match the proof of identity, proof of residence to match the country of residence, etc.), otherwise the participant/winner will be disqualified from the Competition.
- IB Competition is available to all partners that are eligible to register IB account with ETO Markets.
- By participating in the IB Competition, you acknowledge that you have read, and agreed to be bound by, these terms and conditions as well as to the ETO Markets Terms and Conditions.
- Upon completing the IB Competition registration form, ETO Markets will send the acknowledgement to your registered email address.
- Participants agree that information provided during Competition registration may be used by the Company both within the context of the Competition and for any other marketing purposes.
- The Competition starts on Sunday, July 1st, 2018, at 00:00 server time and ends on Wednesday, September 30th, 2018, at 23:55 server time. Details of the registration and completion dates can be found below:

ETO Markets will announce the Top Prize winners within 10 business days from the end of the IB Competition. The winner will be contacted after the competition ended. Should the winner fail to answer, the ETO Markets reserve the right to award the next runner up.
